

## 2023-2024 CONTEST RULES

Create a celebration centered around Human Rights,

### ARTICLE 1:

Among its various activities and challenges our Association Regards d'Enfants organizes the following contest: **"Create a celebration centered around Human Rights, organize, illustrate and give life to the strong values of Human rights"**.

### ARTICLE 2:

This contest should enable kids and youngsters to express their Human Rights conceptions by proposing an event centered around Human Rights choosing and then share it collectively.

### ARTICLE 3:

This contest is open to kids, youngsters or students up to 26 years old who can compete individually or in teams (i.e. schools, leisure centres, youth centres or clubs, day care...)

### ARTICLE 4:

The imaginative participants may **use freely any kind of supports** for the making of the various projects, it is totally free (i.e. paper, cardboard, textile, wood, IT supports, USB keys, DVD, CD...)

### ARTICLE 5:

In order to be selected non digital works should not exceed L 100 cm / W 75 cm / H 30 cm, otherwise **they won't be examined**.

On the reverse side, they should be clearly labelled with the following mentions:

- **"Concours 2022 2023:** Create a celebration centered around Human Rights, organize, illustrate and give life to the strong values of Human rights
- **Name, surname, age, full postal address, country, phone and e-mail of the person in charge as well as the name of the School, centre or club if so. The full postal fees are to be paid by participants.**

### ARTICLE 6:

To be accepted digital works should be read only using freeware or Microsoft Pack Office (Word, Excel, Powerpoint) exclusively. Videos should not exceed 3 minutes.

- Individual works should be labelled as followed: Conc2024\_NAME\_Surname
- Team works should be labelled: Conc2024\_NAMEOFTHESCHOOL(or CENTRE or CLUB)

### ARTICLE 7:

The mandatory typed information/spec sheet, translated into French, has to be sent to Regards d'Enfants. **This document is a must for the Jury members who won't be able to consider the works if missing.** This document is freely sent to participants. ### ARTICLE 8:

The Jury are well-known VIPs professionally strongly- committed to the defence of Human Rights and will be chaired by M.MatjaZ Gruden, Director of democratic participation at the European Council.

The authors and their legal representatives transfer all rights to the Association Regards d'Enfants. The works may be published on any support or in any form.

#### **ARTICLE 11:**

To close the contest an official award ceremony will be held in June 2020 in Strasbourg and the winners with their teachers or tutors will be named "**Human Rights Ambassadors**". Travelling and housing remain at participants' own cost.

#### **ARTICLE 12:**

**The participants taking part in the award ceremony authorize the Association Regards d'Enfants** to reproduce on any support or by any means, and to post without any financial compensation, pictures, movies, recordings where they appear. The above mentioned will be used by Association Regards d'Enfants in order to communicate on its activities.
